## Purpose

- This information is used to calculate price indexes. These indexes measure price changes of goods and services used in, and produced by, the farming industry.
- The survey results are used by Government, farming organisations and research organisations to measure the performance of the New Zealand economy.

3. If possible please supply GST EXCLUSIVE values, ie exclude GST charged on all goods and services supplied by you and exclude GST which you are able to claim back on any expenditure.
